Cllr Flint proposed a grant of £200, seconded by Cllr Finnigan carried unanimously.

Tolzey Hall Refurbishment

The Clerk requested funds for new curtains, vacuum cleaner and desk with drawers. Cllr Munro-Davies proposed £710 to fund these purchases, seconded by Cllr Finnigan carried unanimously.
