District Councillor Feedback

Regarding Policies, Sites & Places (PSP) Marshfield is in a better position than other Parishes because of the Community Land Trust (CLT) which is deemed to be in line with neighbourhood plans. The CLT is thought to be suitable for Marshfield.

Policies, Sites and Places Consultation

Cllr Albon- Crouch has looked at the PSP consultation & discussed with South Glos. & there are no changes to Marshfield. However a major disappointment is the gaps in the housing stock with new housing plans not being adopted until 2018. This is partly due to the Joint Strategic plan is about to be renewed & as a result housing numbers & green belt boundaries may change. This delay may leave us open to speculative house builders. As a community this system leaves us in limbo & uncertain on housing.

Councillors were all in favour of the Chairman responding to the consultation.

Matters for Discussion

South Glos. have advised we can co-opt to fill our Parish Council vacancy.

The next Community Engagement Forum will be held in Marshfield Community Centre on Tuesday 25th October. Cllr Veitch advised that the Cemetery refurbishment was coming along & an excellent job was being done.

Cllr Sweet gave his apologies for the next meeting.
