

Seeing the light! During January all the street lights in Marshfield will be replaced by LEDs (Light Emitting Diode) in 2021. This will reduce energy costs and cut carbon emissions.

It is part of South Gloucestershire Council's programme to convert all 29,500 street lights and 3,500 lit road traffic signs across the district. They



Through this change annual energy consumption in Marshfield is set to fall from 60,000 kwh to under 10,000 kwh. Carbon emissions will reduce from 31 to 5 tonnes. The main change residents will notice is a shift from an orange to a white glow. Further information is available from Marshfield Parish Council.



Powering our Net Zero Future The new <u>Energy White Paper</u> launched in December 2020 puts in place a strategy for the national energy system that:

- transforms energy; cleaner, greener
- supports green recovery; green jobs
- creates a fair deal for consumers; save on bills, protects the fuel poor

It aligns with a commitment to become Net Zero Carbon by 2050 through migration from coal oil and gas to clean fuels for electricity generation, transport, heating and cooking. The targets include more offshore wind, new nuclear generation, carbon capture and storage, emissions trading and electric heat pumps in homes.

It will affect us all through investment strategies and legislation, and individually with changes to domestic heating and transport. Under the 'Consumers' section there is reference to Agile Octopus and Energy Local Clubs and undertakings to consult on improving the energy performance of homes and ending the gas grid connection to new homes.


Management of Ringswell Common

Discussions are ongoing about how to ensure the long term management of Ringswell Common, located south east of Marshfield. The SM Committee has discussed this issue and published the following statement:

'Sustainable Marshfield believes that the protection and enhancement of biodiversity

across the Parish by landowners and appropriate authorities is crucially important.

We are delighted that Marshfield Parish Council (MPC), as landowner of Ringswell Common, is taking on responsibility to determine its future management as a designated Site of Nature Conservation Interest.



There are bound to be a range of views and options about the most appropriate management that take into account biodiversity, farming and community considerations. We are encouraged that the MPC decision will be informed by a range of expert inputs and community views.

We have looked at the Advisory Note compiled on a pro bono basis by local professional ecologist, Martin Smith. This was produced in response to a personal invitation from the owners of Pitt Farm, who manage the land. We believe it offers a good sustainable route forward and are confident that MPC will give it careful consideration alongside specialist advice from South Gloucestershire Council and Natural England.
