Matters arising

- a) Highway Matters – Request from a High Street Resident to ask other residents not to park on the dropped pavement sections to allow access for push chairs and wheel chairs. Cllr Reade advised PC to check the line markings and request a refresh if needed.

- c) Marshfield Community Land Trust – S106 conditions ongoing. The Housing Association has received 15 expressions of interest to tender for the contract.
- d) Sustainable Marshfield – Cllr Veitch asked what was happening to the Weir Pool which is full of tall grass again. PC to liaise with SM regarding the cutting of the bank either side of the pool and the clearing of the grasses from the pool. Cllr Reade arranging a walk around to look at the verges as part of the verge management programme.

Mark Gaylard explained the reasoning and the intention to leave some trees on the steep bank.
PC recognise they are doing the work within their Grazing rights but requested that they engage with Sustainable Marshfield to strike a balance between grazing and a natural habitat for wildlife.
