## **Matters arising**

- Highway Matters Cllr Hogben commented on the bad condition of the pavement on the north side of the High Street. He will do a survey and it will be reported to South Glos.
- b) Marshfield Outdoor Recreation Association- The bins at Withymead have now been emptied and all is back on schedule.
- Local Housing Requirement- The CLT has now secured a 1.6 acre site at Garston Farm for 18 houses. A meeting has been held at which 106 residents attended and at the show of hands 100 approved and 6 abstained. The next stage is completing a feasibility study and the Housing Needs Survey which ends in September will be used as evidence for the planning application.

#### **Gleeson Strategic Land**

Peter Rawlinson from Gleeson was invited to the meeting following receipt of their letter advising that they had submitted the land next to the school to South Gloucestershire in their call for sites and are promoting it for residential development.

Mr Rawlinson advised that the initial thoughts were for 80-100 houses plus a new doctors surgery but this is not a set figure. Mr Rawlinson confirmed that policy needs to be confirmed but at present 35% would need to be affordable housing but they would not necessarily go to Marshfield residents. It will be some time before they know if South Glos. allocate the land in the local plan. However SGC have said that they would be more favourable to smaller sites.

Mr Rawlinson also confirmed that they would continue to promote the site even if the village was against development as they were working for the land owner.

It was commented on that even though many people thought the school was full this is not the case for the last 2 years intakes.
