Proposed by Cllr Veitch, seconded by Cllr Hogben, carried unanimously.

Items from the public

Request to speak at discussion of Planning Application 11 and 10 Barn End.

Matters arising

a) Highway Matters – 100m stretch of Tormarton Road from Rushmead Lane to be closed for 3 days from 17th November.

The Give Way sign at the Junction of Chippenham Road and the A420 is pointing the wrong way. PC to report to StreetCare.

PC to request cutting back of Hedges in Ayford Lane as restricting vision for vehicles.

PC to pursue a response from SGC re the temporary access for the development of the Barn behind 143 High Street.

- b) Marshfield Outdoor Recreation Association From 1st October the Withymead gate will be closed at 8pm.
- c) Marshfield Community Land Trust Contract out for tender, the Housing Association will decide which Contractor to go with. The energy generation consultancy report is under consideration.
- d) Sustainable Marshfield LNAP Zoom meeting 14th October 3pm. Local Produce Market at Community Centre this Saturday 2nd October. The Apple Press will also be there.

Planning

- 50 Hayfield. Works to crown reduce 1 Beech tree by 2.5m and remove the lowest branch. (P21/06020/TCA)

No objection proposed by Cllr Veitch, seconded by Cllr Homent, carried unanimously.

- Pitt Farm 3 East End. Demolition of modern extension and stone sheds. Partial conversion of stables to living accommodation and erection of a single storey rear extension. Works to windows, internal works and landscape alterations. (P21/05970/F) and (P21/05971/LB)

No objection proposed by Cllr Veitch, seconded by Cllr Brooks, carried unanimously.

- The New House 11 Barn End. Works to fell 1 Horse Chestnut tree. TPO 42/18 (18^{th} March 2018) (P21/06233/TRE)

The Parish Council strongly object to this application as a tree survey has shown that the tree has at least 10 years of life in it, it has a TPO and is situated alongside other trees with an integrated root system. However, if the tree is found to be unsafe then the PC would request that a replacement native tree be planted in the same site. Proposed by Cllr Hogben, seconded by Cllr Veitch, carried unanimously.

- 10 Barn End. Erection of single storey outbuilding to form garden room/office. (P21/06208/F) The Parish Council would strongly object to this Application if the development is to be positioned on Open Green Space land. The PC request clarification of this. Proposed by Cllr Veitch, seconded by Cllr Snow, carried unanimously.

- 78 Hayfield. Works to crown reduce 1 Beech Tree by 3.5 metres to leave a finished height of 7.5 metres and a radial spread of 4 metres. Tree situated within the Marshfield Conservation Area. (P21/05900/TCA)
- 92 High Street. Works to fell no.2 Holm Oak trees situated in the Marshfield Conservation Area. (P21/05296/TCA)
- Land adjacent to Tormarton Road and Rushmead Lane. Change of use from agricultural to private equestrian. Erection of one stable block (P21/05100/F)
- Springs Farm. Demolition of existing farm building, conversion of barn to form one dwelling and erection of detached garage. (P19/00092/F)

Weir Pool
