- a) Highway Matters - Suez waste contractor taking industrial action 26th June - 9th July. Collections maybe disrupted again. Land South of The A420. Installation of 15.0m Phase 8 Monopole and associated ancillary works.
P23/01813/PN1

A representative from Windhager addressed the Council expressing concerns over the suitability for the placement of a 15m monopole directly outside the building as well as in an AONB and a Conservation Area. The Parish Council strongly objects to this Planning Application on the grounds that it would rise above the skyline of the village and be seen from all directions. The placing of this pole is not suitable for a village in a Conservation Area and an AONB. Strong Objection proposed by Cllr Christie, seconded by Cllr Hogben, carried unanimously.
