Confirmation of previous minutes

Proposed by Cllr Finnegan, seconded by Cllr Veitch, carried unanimously.

Items from the public

Andrew Witts spoke to the PC about the role of a school governor at Marshfield Primary School and advised that there was a vacancy which would ideally be filled by a local Parish Councillor. Cllrs who may be interested to contact Andrew directly.

Matters arising

- a) Highway Matters – Closure of Ayford and Oakford Lane (from 3rd July) and part of Ashwicke Lane 25th July. PC to clarify with SGC what works are taking place as following discussions with Cllr Reade, blocked drains are thought to be the problem, cc correspondence to Cllr Stokes. Suez waste contractor taking industrial action 12th -18th June and again 26th June - 9th July. Collections maybe disrupted.
- b) Marshfield Outdoor Recreation Association – Nothing
- c) Marshfield Community Land Trust – Housing Association have signed off the scheme, looking at complete sign off end of June.
- d) Local Environment – Wild verges are doing very well.

No objection subject to Conservation/Historic England approval of scheme and assurance that the affordable homes will remain so in perpetuity proposed by Cllr Finnegan, seconded by Cllr Hogben, carried. Cllr Veitch abstained from voting.
