Withymead Playing Fields. Works to 2 groups of mixed trees comprising of Sycamore, hazel, elder and hawthorn. Cut back lower branches overhanging the 'play fort' back to previous points, and cut back lower branches encroaching into the 'zip line' back to previous points (up to 1m) P25/00276/TCA

Henley Hill Barn Ashwicke Road. Installation of 1 swimming pool and erection of 1 pool plant/store room. P24/02878/HH
